The abandoned boats below are located on L Dock. Staff will be onsite for access to parking. Park in the spaces by the launch ramp. The JKL dock gate is on the east side of the launch ramps.

If you wish to place a bid for any of the boats, please fill out the bid form completely, seal it in the provided envelope and fill in the Lot number on the envelope. Please use a separate bid form and envelope for each boat you are bidding on. You must turn in the sealed envelope with the bid form enclosed to the designated Chicago Harbor Manager by 2:30 pm at the office on the deck by the JKL dock gate.

At 2:30 pm there will be a public opening of all bids at the office on the dock by the JKL gate. The winning bidder will also be notified by email within 3 business days.

The winning bidder must make payment within 14 days by cash, cashiers check or credit card to the Chicago Harbors Office, 1521 S. Linn White Drive, 1st Floor South, Chicago, IL 60605. All boats are sold as is and neither the Chicago Park District nor Westrec Marina SMI offer any warranty or guarantee for any boat purchased. The purchaser will be responsible for removing boats from the harbor within 14 days.
